### ***KNOCK, KNOCK: The Art of Wit and Whimsy***

Livermore Valley Arts presents an exhibition called ***Knock, Knock, The Art of Wit and Whimsy*** at the UNCLE Credit Union Art Gallery at the Bankhead Theater Oct 23, 2025 through Jan 4, 2026.

**Knock, Knock: The Art of Wit and Whimsy** invites viewers to step into a world where humor and imagination take center stage. This lighthearted and joyful exhibition celebrates the playful side of creativity, showcasing artwork that elicits laughter, sparks delight, and nudges the imagination in unexpected directions. From visual puns and satirical commentary to reimagined board games and comic-inspired illustrations, each piece reveals how art can be both clever and carefree.

Featuring a vibrant mix of media—paintings, illustrations, sculptures, photography, and mixed-media works—the exhibit highlights artists who embrace levity without sacrificing meaning. ### **Entry:**

- Please submit entries electronically. Upload to 3 electronic images to [agiancola@lvpac.org](mailto:agiancola@lvpac.org) by Fri Oct 1, 6pm. **Include your name, titles of pieces, size and price for sale or NFS.** We will accept up to three works. No overtly religious or controversial pieces will be accepted. The work will be juried by LVA staff. Submit images as separate 300 dpi jpg attachments, size not to exceed 1920 x 1920 pixels. Title the jpg image files in the following format: LastnameFirstname\_Title\_Medium\_size\_price (ie. DoeJohn\_kimono\_silk\_24x16\_200).

Subject line to read: Knock

- \$35 entry total for up to 3 images. Once entry is submitted, fees are non-refundable regardless of acceptance into the exhibition.

### **Hanging instructions**

Work must be wired and ready to hang by a wires/hanging system and/or nails. “D” hooks are strongly recommended for the wiring. A label should be attached to the back of each artwork listing your name, the title of the work, price, and medium. Please contact [gallery@lvpac.org](mailto:gallery@lvpac.org) if you have any questions on hanging.

Upon delivery, artists will be required to sign the release form attached, giving Livermore Valley Arts the right to exhibit their work and waiving liability in the event of damage or theft. Please print, sign and return to Anne Giancola at [gallery@lvpac.org](mailto:gallery@lvpac.org)

Livermore Valley Arts does not provide insurance for work that is damaged or stolen.

If you are **shipping** accepted artwork, it must be received by September 29, 2025. Ship artwork carefully, in a box, with padding. We will return it to you in the same box, only if there is return postage by label or bill of lading from UPS, Fedex, or USPS. Livermore Valley Arts will not be held responsible for theft of art nor damage during shipping to and from the gallery. Ship to LVPAC, 2400 First St., Livermore, CA 94550. Any work that is not picked up within 1 week or is not prepared for return shipping will become the property of Livermore Valley Arts. Livermore Valley Arts does not provide insurance for work that is damaged or stolen.

### **Details**

All work must remain up for the duration of the show.

Livermore Valley Arts will handle all sales and send payment to the artists.

**If your artwork sells, there will be a 4% credit card processing fee and then 70% will go to the artist, and 30% to the gallery.** Livermore Valley Arts requires artists to complete a W-9 in order to complete payment to the artist. The artist is responsible for paying all sales tax. The Gallery does not add sales tax to price, so please price accordingly. You will receive payment up to 30 days after close of the show.

Livermore Valley Arts will make every effort to promote the exhibition through invitations and other forms of publicity. Email images of the show announcement and printed postcards will be available for distribution to artist’s personal contacts.

### **ART DISPLAY WAIVER OF LIABILITY AND INSURANCE AGREEMENT**

This Agreement is entered into between Livermore Valley Arts (the “Host”) and Artist full name (the “Artist”), collectively referred to as the “Parties.”

#### **1. Exhibition of Artwork**

The Artist agrees to display one or more original works of art (collectively, the “Artwork”) in the public lobby areas of the Host’s premises, including but not limited to The Independent and the Bankhead Lobby, from Oct 2 through Jan 4, 2026 or until otherwise agreed upon by both Parties in writing.

#### **2. Waiver of Liability**

The Artist hereby releases, waives, and discharges the Host, its owners, employees, agents, and affiliates from any and all liability, claims, demands, actions, or causes of action whatsoever arising out of or related to any loss, damage, or theft of the Artwork while on display or in transit to/from the display location, whether caused by negligence, accident, vandalism, or any act of God, including but not limited to fire, flood, earthquake, or other natural disasters.

#### **3. Insurance Recommendation**

The Host advises the Artist to maintain appropriate insurance coverage for the full value of the Artwork while it is in the possession of or displayed by the Host. Such insurance should cover loss or damage due to negligence, theft, fire, vandalism, and natural disasters. The Host will not provide insurance coverage for the Artwork and assumes no financial responsibility for the Artwork under any circumstances.

#### **4. Indemnification**

The Artist agrees to indemnify and hold harmless the Host from and against any and all claims, damages, liabilities, costs, and expenses arising out of or related to the exhibition of the Artwork, including claims made by third parties.

#### **5. Condition and Removal of Artwork**

The Artist is responsible for delivering the Artwork in good condition and for removing it promptly at the conclusion of the display period. Any costs related to transportation, installation, or removal are the responsibility of the Artist.

#### **6. Entire Agreement**

This Agreement constitutes the entire agreement between the Parties and supersedes any prior understanding or representation of any kind preceding the date of this Agreement. Any modifications must be in writing and signed by both Parties.
